### Vendor Application Form

- **Booth fee is \$40.00.**
- **Booths will open at 9 am in Gold Star Park near S. Main Street and must remain open until the parade has concluded (approximately 2:30 pm).**
  - **Space for booths will be a minimum of 12x12. Booths should feature concessions, arts and crafts, jewelry, clothing, etc.**
- **Food vendors must submit their entry form no later than February 10<sup>th</sup>, 2023. (All food vendors are submitted to the Elmore County Health Department for approval).**
  - **Limited electricity is available and is offered on a first come, first serve basis. Generators are permitted.**
  - **Each vendor application is accepted unless otherwise stated. Set up instructions will be provided the week before the festival.**
    - **The Order of Cimarrón reserves the right to relocate vendors due to late arrivals, no shows, etc.**
- **To prevent excessive duplication, the sale of certain food items may be subject to limitation at the discretion of the Vendor Committee. NO VENDOR WILL BE GRANTED EXCLUSIVE RIGHTS TO ANY FOOD ITEM, DRINK, OR ARTS AND CRAFTS.**
  - **Food vendors must be able to meet Health Department regulations for food storage and preparation.**
  - **Push Car vendors must adhere to any safety directions issued by the Vendor Committee or Security Personnel.**
